Clarence Children's Services is sponsored by Clarence City Council. We operate Before and After School Care and Kinder Care services in the Montagu Bay school hall.







At our service, children are encouraged to participate in supervised activities that are based on the children's interests. Our service offers a variety of indoor and outdoor activities as well as the opportunity to relax and spend time with friends. We also offer guiet times and areas for rest or homework.

We also operate holiday programs during the school holidays at Montagu Bay and Lindisfarne Primary schools, and at our Alma St service in Bellerive.

Our fees are per session and your out of pocket cost is determined by your eligibility for Child Care Subsidy (CCS).

> Before School Care operates from 7:30am – 8:30am Full fee: \$15.00

> After School Care operates from 2:45pm – 6:00pm. Full fee: \$37.00

Kinder Care operates from 12:45 – 2:45pm Wednesday Full fee: \$24.00

Late Collection Fee (charged for every 15 minutes after 6pm)	\$41.60	per child
Late Payment Fee (applied to overdue accounts not paid within the 7-day terms)	\$38.30	per account

- After/Before School Care (permanent bookings) absences must be reported to the Clarence Children's Services Office by the cutoff times mentioned above to be charged an absent fee. If notification is received after the cut-off or no communication is received
  for an absence, then the Non-Cancellation fee will be charged.
- Absences for casual/roster bookings must be reported to the Clarence Children's Services Office by the cut-off times mentioned
  above to be charged an absent fee. If notification is received after the cut-off or no communication is received for an absence, then
  the Non-Cancellation fee will be charged. Casual/roster absent fees will be removed if the service receives more than 14days notice
  of an absence.
- Holiday Care absences will be charged at the full session fee if less than 7days notification is given. Holiday Care absence fees will be applied when more than 7days notice is given, or if a medical certificate is provided. Holiday Care fees will be removed if the service receives more than 14days notice of an absence.
- All absences must be notified via the OWNA app, or to 03 6217 9610 or oshc@ccc.tas.gov.au, not the direct mobile numbers at the OSHC locations.
- Requests to temporarily cancel any permanent bookings must be made in writing to oshc@ccc.tas.gov.au and decisions are at the discretion of the Program Coordinator.
- Payment terms are strictly 7 days from date of invoice. Late payment of your account will attract an additional fee. The Program
  Coordinator reserves the right to cancel care arrangements and forward the account to Tasmanian Collection Service if the account
  is over 14 days overdue and a payment plan is not in place.
- For families eligible for Child Care Subsidy:
  - o Your out-of-pocket cost is determined by your eligibility for Child Care Subsidy (CCS)
  - o Families experiencing financial hardship may be eligible for Additional Child Care Subsidy (ACCS) which covers 100% of the cost of care.
  - o Please ensure any changes to your income and/or work activity details are updated through your MyGov account.
